#### THE FOLLOWING WILL NOT BE PERMITTED:

1. Sending or displaying of offensive messages or pictures
2. Using obscene language
3. Harassing, insulting, or attacking others
4. Damaging computers, computer systems or networks
5. Violating copyright law
6. Downloading MP3's, videos, or accessing sites for file sharing
7. Using another person's password
8. Looking in another person's folders, files or work
9. Wasting time
10. Using instant messaging or looking at personal email
11. Downloading or installing unauthorized software
12. No blog sites such as: My space, xanga, facebook, bebo or any other online blog site.
13. No emailing, no instant messaging, or text messaging via internet.
14. Posting or distributing libelous or defamatory material, literature, or material containing a threat of violence, injury or harm.
